It is a unique opportunity to imagine the possibilities of what this might look, feel, smell, and taste like, and at the same time contribute to actions that can take us towards that future and make it happen. It might even save you money!

None of us can predict or know exactly what that future might be like or make us feel. Yet together if we all do our part, we can work towards a better District. On Saturday 9 March from 10am to 4pm there will be a range of fun and creative activities and exhibitions at the leisure centre, literally something for everyone, including:

- A Cabaret and Trash-ion Show performed by students from South Staffordshire College and Staffordshire University Academy in Hednesford;
- Future ideas and inventions;
- Museum of Curiosity;
- Windmills and solar technology;

- Mini beasts;

Schools will be the focus of attention on Friday 8 March. Preliminary workshops have been taking place with local schools since January. Later that day, between 6pm and 8pm, the attention switches to businesses when there will be a Business Workshop hosted by Kate Copeland-Rhodes, Director of the influential Globe Foundation based in nearby Uttoxeter.

The whole two-day event will be presented by The House of Fairy Tales, a person-centred arts and education organisation which has worked with the National Trust, Royal Shakespeare Company and the Tate Modern in London. The emphasis will be on fun and engagement to help all of us live more sustainably - and help tackle climate change at the same time.

# BAG IT AND BIN IT, THAT'S THE RULE!



'Foul Play' is a new campaign which has been developed by the Council's Environmental Health and Policy and Communications teams in partnership with the Community Wellbeing Team at Inspiring Healthy Lifestyles (IHL).

Foul Play focuses on the impact of not picking up after your dog and encourages children to have conversations with adult family members about the importance of being a responsible dog owner.

The campaign promotes important messages to show the impact of dog poo not being picked up. These messages focus on the environment, children's play, health and general annoyance.

Schoolchildren from five local schools including St Peter's Primary Academy, Five Ways Primary, Heath Hayes Academy, St Mary's Primary, and

> Chancel Primary helped Officers create this campaign. Pep the Poet and Roots the Illustrator visited local schools last September and worked with children to develop words, images and into the campaign.

These are now displayed around the school grounds for dog owners to see when they are passing each school.

Officers from the Council's Environmental Health Team are continuing to carry out regular patrols around these school sites to ensure the message is being adhered to and dog owners are picking up after their dogs.

# Local Plan

#### The Cannock Chase Local Plan looks at development of housing and employment land across the District, where it should go and where it should be restricted.

Our latest consultation is the last chance for residents and businesses to comment on the Cannock Chase Local Plan 2018-2024 before it is submitted to the Government's Planning Inspectorate for examination.

The six-week consultation will give people the opportunity to make their views known on the finalised plans and associated documents. The consultation runs until **5pm** on **Monday 18** March.



# Keeping our communities safe

The Community Safety and CCTV team at the Council work hard to keep our District safe for residents and visitors alike.



The Council's CCTV service monitors 98 public space surveillance cameras 24/7 across the District, for the purposes of detection of crime and to help increase public confidence. Over the last 12 months, 3,372 incidents of 'evidential value' were captured by CCTV. Trained and experienced operators continue to detect and help the Police secure arrests for those suspected of shoplifting, theft, burglary, criminal damage, ASB, drink driving and offences against the person - while also detecting missing people and safeguarding those who are vulnerable.



#### Safer Streets 5

£500,000 is to be invested in preventing and addressing anti-social behaviour and associated crime in Cannock South and Cannock West wards, as part of the Government's Safer Streets Five Fund. This follows a successful bid and plan submitted to the Home Office by the Staffordshire Commissioner's Office, which identified and nominated the two ward areas.

Interventions have been designed and focused on where there is strong previous evidence of positive outcomes and includes:

- Target hardening;
- New and improved CCTV;
- New and improved streetlighting;
- Taxi marshals;
- Environmental improvements; and
- Educational products directed towards early intervention, behavioural and attitudinal change.

The project will be managed and delivered by the Community Safety Team and is operational until 31 March 2025. Resident s will see the first improvements within the next couple of months.



#### What we fund

The Community Safety Team receive funding from the Staffordshire Commissioner. This has enabled the team to fund the following this year:

**ASB diversionary activities -** An annual package of activities for the District, helping to divert young people from ASB.

**PSHE programme -** An in-school engagement project which teaches students about a wide range of issues including child sexual exploitation, grooming, exploitation into crime e.g. County Lines and knife crime, extremism and alcohol abuse.

**Substance Misuse Worker -** A support worker to develop and enhance independent living skills - helping people re-integrate back into the community following an abstinence-based rehabilitation programme.

**Target hardening -** A cross-District project, to target harden areas which have attracted ASB, violence, drug use and general criminality.

**Knife crime awareness/prevention -** Awareness sessions in secondary schools, delivered by a mother of a victim and anti-violence campaigner.

Bicycle marking - Free sessions across the District to help reduce the theft of bicycles.

Safer Community Grants - Grants to improve home security for those vulnerable to crime.

**Drink spiking testing strips -** Testing strips provided to licensed premises to raise awareness of, and safeguard people from, drink spiking.

Purse charms - Anti theft device distributed to assist with the prevention of 'pickpocketing'.

Faraday pouches - Signal blockers to help reduce keyless car theft.



#### Did you know...

This partnership working has helped the Police to achieve a 3% reduction in all crime across the District over the past 12 months.

# New park developments continue across the District



Outdoor spaces are essential in enabling the residents of Cannock Chase District to have access to healthy and active lifestyle choices. That's why the Council is continuing to invest in these much-needed facilities across the District.

The Council is committed to providing good quality parks, play areas and open spaces for all to enjoy and is working on redeveloping and improving several parks and play areas this year including the following:

#### Cannock Park

The Council is currently consulting on £585,000 improvement plans for Cannock Park.

This will be part of the capital programme of works for 2024/25 and will be financed by £250,000 Section 106 monies, £200,000 CIL (Community Infrastructure Levy) monies and a £15,000 grant from the Forest of Mercia. An additional £120,000 will be allocated from the Safer Street 5 Fund for CCTV and lighting works. This takes the overall budget for the redevelopment works to £585,000.

Council officers were on site last month to encourage users to 'design their new play area' as part of a wider engagement programme. This has also included workshops with local schoolchildren and community groups who have been given the opportunity to get involved in the design of the toddler and junior play areas.

The consultation will close on Sunday 31 March.

#### Laburnum Avenue

Works are still progressing at the Laburnum Avenue Recreational Area with new fencing being installed around the site.

A contractor is due to be appointed shortly for the new play area which went out for tender last month. Once a contractor has been appointed, further engagement opportunities will be announced for the design of the new play area.

The Council is currently awaiting confirmation from the Environment Agency in relation to the replacement of the bridge. Once this has been agreed, works will commence on this part of the scheme.

Future updates will be available on the Council's website and social media sites as and when plans progress.

#### **Cannock Stadium Skatepark**

An exciting new Skatepark is coming to Cannock Stadium this summer as part of the ongoing redevelopment works for the site.

The Council has appointed Canvas to develop this new facility and it is currently working on the overall design of it. Residents and skatepark users can have their say on the proposed design by completing a short survey online via the Council's website www.cannockchasedc.gov.uk/newparks.

Officers were also on-site last month with the help of the Friends of Cannock Stadium to speak to people about the design of new skatepark.

The consultation will close on 31 March.



# Keeping the streets of Cannock Chase clean

Every year the Council cleans 350km of streets picking up over 3,000 tonnes of litter and emptying approximately 600 litter bins every week.

#### We all want to live in a litter free and clean environment but we need to work together to achieve this.

Our aim is to:

- Litter pick all streets at least once every two weeks, with shopping areas picked daily
- Mechanically sweep the District's gutters on a regular programme and sweep town centres daily
- Remove litter and dog fouling
- Empty street litter bins at least once a week and more often in shopping areas
- Clear fly tipping within three days of notification
- Remove offensive graffiti within 24 hours and all other graffiti within seven days

Please help us by:

- Not dropping litter on the streets
- Disposing of waste in the proper place
- Not putting sharp objects such as needles in litter bins
- Telling us if you see an overflowing litter bin
- Keep play areas clear of litter, broken glass and dog fouling

#### Did you know...

We have a supervisor, three town centre operatives for Cannock, Rugeley and Hednesford. We have a mobile litter team that litter picks District roads and open spaces. Also, a team that cleanses play areas and empty's litter bins and a precinct sweeper and channel sweeper.

We have lots of individual residents that do regular litter picks and also groups lead by the following Councillors across the District.

Graham has been working for Cannock Chase Council for 37 years, and as a town centre operative in Rugeley for seven years.


#### What are the most challenging aspects of your job?

# **LET'S HALVE** FOOD WASTE **BY 2030**

#### The Council is joining Love Food Hate Waste's annual campaign in their effort to halve food waste by 2030.

4.7 million tonnes of edible food is thrown away each year by UK households. Shockingly, 25% of this wasted food is because of people cooking, preparing or serving too much - this costs UK households £4.9 billion each year.

The campaign will focus on 'Choose What You'll Use' and will highlight the benefits of buying loose fruit and vegetables and inspiring people to do this wherever they can.

# Local elections this May will be different

#### **Elections to Cannock Chase Council take place** on Thursday 2 May but this time there will be some significant changes, as follows:

- Changes to every ward except Norton Canes, with wards changing boundaries and some new ward names to note:
- A reduction in the number of wards from the current 15 to 12;
- Fewer councillors being elected down from the current 41 to 36 (there will be three councillors per ward from May's elections); and
- Every single ward being contested this time in three out of every four years in the past there has been election 'by thirds' (i.e. a third of the total number of wards contested)

The 12 new wards are: Brereton and Ravenhill, Cannock Longford and Bridgtown, Cannock Park and Old Fallow, Chadsmoor, Etching Hill and The Heath, Hawks Green with Rumer Hill, Heath Hayes and Wimblebury, Hednesford Green Heath, Hednesford Hills and Rawnsley, Hednesford Pye Green, Norton Canes, and Western Springs.



# THE DEADLINE FOR REGISTERING **TO VOTE IS:** Did you know... The changes follow a review

of the ward boundaries that make up Cannock Chase District. Carried out by the independent body, the Local Government Boundary Commission for England, it involved consultation in 2022, and then again in 2023 on the Commission's proposals.

As the boundary changes will have come into being, residents should check carefully their poll card details as there will more than likely be changes. This will confirm the polling station where they can vote.

There are also some other significant changes being brought in by the Elections Act 2022 such as applying for a postal or proxy vote and the removal of the 15-year limit for overseas electors.

Helpful guidance on voting at elections which covers the above, including all the requirements around Voter ID and what to do if you don't have ID, can be found on the Electoral Commission's website at

www.electoralcommission.org.uk/voting-andelections

Residents should also note that Voter ID will again be required at the May elections and it is not too late to register to vote or apply for voter ID.

The Council will be sending out poll cards to residents already registered to vote from **26 March.** If residents have recently moved house or are just turning 18, they can still register to vote up until midnight on 16 April at www.gov.uk/register-to-vote.

#### Did you know...

The elections on 2 May will be combined with the Police, Fire and Crime Commissioner election for Staffordshire.

# TACKLING IRRESPONSIBLE let's talk DOG OWNERSHIP

The Council's Environmental Health Team has joined forces with dog behaviour experts Let's Talk Dog to tackle irresponsible pet ownership across the District.

Irresponsible dog owners contribute to a large proportion of anti-social behaviour concerns and the Council receives many complaints relating to dogs, including noise from barking, dog fouling, dogs off leads and stray dogs.

With the support and expertise of the team at Let's Talk Dog, the Council is aiming to educate pet owners about how to be a responsible dog owner as well as encouraging dog owners to care for their dogs properly.



Did you know... A series of short videos have been produced for each of these areas

which provide useful tips as well as highlighting the responsibilities of dog owners.

The campaign will focus on four areas including nuisance dogs, uncontrolled dogs, animal welfare and potentially aggressive dogs.

Let's Talk Dog will also be hosting two training and behaviour classes this month. These classes will focus on helping owners avoid potential behaviour issues and modify problem behaviour using simple, kind, reward-based methods.

Funding for this project has been allocated from Cannock Chase Council's Community Safety Team's Anti-Social Behaviour Reduction Fund. This fund is provided by the Police, Fire and Crime Commissioner for Staffordshire.

#### Sessions will run on **Tuesday 12 March, 10am-1pm** at Cannock Fire Station and Tuesday 26 March, **10am-1pm** at Rugeley Fire Station.
