2. Nomination papers must be delivered to the Returning Officer, Civic Centre, Beecroft Road, Cannock, Staffs., WS11 1BG on any day (excluding weekends and bank holidays) from Monday 25th March, 2019 until Wednesday, 3rd April, 2019 between the hours of 10 a.m. and 4 p.m.
3. If any election is contested the poll will take place on Thursday, 2nd May, 2019.
4. New applications to register to vote must be received by the Electoral Registration Officer at Civic Centre, Beecroft Road, Cannock, Staffs., WS11 1BG by 12 midnight on Friday, 12 April, 2019. Applications can be made online: www.gov.uk/register-to-vote.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Civic Centre, Beecroft Road, Cannock, Staffs., WS11 1BG by 5 p.m. on Monday, 15th April, 2019. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Civic Centre, Beecroft Road, Cannock, Staffs., WS11 1BG by 5 p.m. on Wednesday, 24th April, 2019.
6. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Civic Centre, Beecroft Road, Cannock, Staffs., WS11 1BG by 5 p.m. on Thursday, 2nd May, 2019. The physical incapacity must have occurred after 5 p.m. on Wednesday, 24th April, 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 p.m. on Wednesday, 24th April, 2019.
