# Foreword from the Leader of the Council



I am aware that receiving a demand for Council Tax payment is not going to be popular with residents right now, especially with the cost of living crisis, which is why it is important to inform you what Cannock Chase Council does with its share of your council tax payment as my Foreword explains.

### Council Tax in 2023/24

In this next 12 months our wide range of services will be provided to you for **£4.56 a week (based on an average Band D property).** About 11.5% of your overall Council Tax bill goes to Cannock Chase Council to provide our services. The remainder is collected on behalf of Staffordshire County Council and the Staffordshire Commissioner (Police & Crime and Fire & Rescue) to fund their own services.

**C** For our contribution - costing about **65p a day we deliver services in over 40 different areas.** They include collecting and recycling your waste, providing leisure and cultural facilities and services (via our partner Inspiring Healthy Lifestyles), award-winning parks and green spaces, housing and homelessness services, planning and building control, and environmental health services.

Council Tax will increase by 2.99% from 2023/24 which will make a Band D property's Council Tax charge £236.92 for the next year.

We believe this small rise in our share is necessary to protect the frontline services and our range of discretionary services that you depend upon.

## What we achieved over the last 12 months

- Successfully staged the Commonwealth Games' mountain biking event at Cannock Chase Forest and the Queen's Baton Relay - legacies coming this year include new interpretation and signage for the Cannock Chase Heritage Trail;
- Progressed the £20m project for Cannock town centre, securing land and buildings we need, shaping our designs and consulting on our vision;
- Achieving six Green Flags for our parks and green spaces - putting us among the best in the West Midlands;
- Secured £3m from the UK Shared Prosperity Fund which will fund a range of economic and community initiatives;
- Published a climate change action plan to become carbon neutral by 2030;
- Launched a new dual stream service to improve recycling rates;
- Ran a Binworld theatre in education project to encourage the next generation of recyclers;
- Agreed to refurbish several play areas and Elmore Park toilets in Rugeley;
- Staged several community engagement events with partners in Rugeley, Cannock and Hednesford; and
- Agreed to share a single management team and our services with Stafford Borough Council, to be more efficient and maximise the impact we can make locally, regionally and nationally;

#### Looking ahead to 2023/24

What is certain in the next 12 months is that there will be a degree of uncertainty. Who could have predicted we would be welcoming refugees from Ukraine, that energy prices would soar and, with it, inflation? But what is certain is that councillors and officers alike will do all they can to deliver value for money and good services, whatever the challenges.

Key activities will be:

- Development of town centres;
- Allocating the UK Shared Prosperity Fund, with all parts of the District benefitting;
- Launching a new Council website and customer relationship management system to improve the way we serve you;
- Doing our bit to become carbon neutral and encouraging residents and businesses to follow suit;
- Making a success of shared services working with Stafford Borough Council, by transforming the way we work to attract new funds and to be influential while also protecting our own identity

These key activities apart, there are a multitude of service tasks and planning going on each day to provide the services you rely on. Many are rather 'unsung' but they all matter and contribute to living and working successfully in our District. They will all be part of our work in 2023/24.

## Our Budget to fund work in 2023/24

From its General Fund the Council aims to spend £14.941m (net income) in 2023/24. This money will be spent on providing Council services.

Our separate Housing Revenue Account has a £20m budget to fund the District Council's Housing Services and comes from the rent that tenants pay us. The Council has a 30-year sustainable Business Plan for its housing stock. An HRA Housing Investment Fund exists and amounts to £12.9m and is there to build new Council houses for those in high priority need.

## Our priority areas and performance

Last year we produced a new Corporate Plan for 2022-26 which has four priorities: Economic Prosperity, Health and Wellbeing, The Community, and Responsible Council We are currently delivering 67 projects related to these priorities in 2022/23, with 89% already completed or on track by the end of December 2022.

- Your Council Tax is based on the valuation band of your property and on two adults living in that property.
- Discounts, reductions and exemptions are available based on your circumstances.
- If you are unemployed or on a low wage, you may be able to get your bill reduced. If you think that you may qualify for this reduction, please visit our website and use the online calculator www.cannockchasedc.gov.uk/benscalc

#### Could I get a discount or reduction on my bill?

This depends on the number of adults in your house and their circumstances. If any of the adults are on the list below, they may not be counted for Council Tax purposes. If this takes the number of 'counted' adults below two, you are eligible for a discount.

- Full time students, student nurses, apprentices, youth training trainees and foreign language assistants
- Young people for whom child benefit is payable and 18/19 year olds who have just left school or college
- Patients resident in hospital or being looked after in care homes
- Severely mentally impaired people
- People in hostels or night shelters
- Low paid care workers usually working for charities
- People caring for a person with a disability who is NOT their partner or child under 18
- Members of religious communities such as monks or nuns
- People in detention (except for non-payment of Council Tax or a fine)
- Spouses or dependants of students who are non-British subjects and are prevented by immigration regulations from working or claiming benefits
- Members of visiting forces, certain international and defence organisations and those with diplomatic privilege or immunity.

## Reduction for people with disabilities

Your bill may be reduced if you (or someone who lives with you) need a room, an extra bathroom or kitchen, or extra space in your property to meet the required needs arising from a disability.

The bill may be reduced to that of a property in the band immediately below the band of your property. If your property is in Band A, a reduction (equivalent to a band) will be given. This reduction is not based on your income or savings.







## **Annexe Discount**

A discount of 50% may be applicable to a separately assessed annexe (or similar self contained part of a property) which is occupied as part of the main property or is the main home of a relative of the council taxpayer of the main property.



## Empty and second homes

Council tax on empty or second homes in the Cannock Chase area will be payable as follows:

The Council Tax team can give you more information about how the above charges may affect you and may be able to refer you to someone who can give you advice about bringing your property back into use.

## Could I be exempt from Council Tax?

Some properties may be exempt from Council Tax. Unoccupied properties which are:

- Owned by a charity (allowed for up to six months)
- Left empty by someone who has gone to prison
- Previously occupied by a person in permanent residential care
- Owned by the estate of a deceased person and waiting for probate or letters of administration to be granted (continuous for up to six months after being granted)
- Empty because occupation is forbidden by law
- Waiting to be occupied by a minister of religion
- Left empty by someone who has moved to receive personal care by reason of old age or disability
- Left empty by someone who has moved to provide personal care to another person
- Owned by a student and last occupied by a student
- Subject to a Repossession Order
- The responsibility of a bankrupt person's trustee
- A site for a caravan, mobile home or mooring
- Unable to be let separately because it is linked to, or in the grounds of, another property and planning conditions do not allow separate letting.

Occupied properties where:

- All the residents are students
- The property is used for UK armed forces accommodation, whether occupied or not
- At least one liable person is a member of a visiting force
- All residents are less than 18 years old
- All liable residents are severely mentally impaired
- At least one liable person is a foreign diplomat
- The property is annexed to a family home and occupied by that family's elderly or disabled relatives

## Can I appeal against my Council Tax band?

There are several situations where you can appeal against the band in which your house has been placed:

- Within six months of becoming the new tax payer for the property.
- Within six months of the Valuation Office Agency making a change to the band.
- If there have been specific material changes in the property value.

## What if I don't think I should be paying Council Tax?

You can appeal to Cannock Chase Council if you think you are not liable to pay Council Tax, for example because you are not the resident or owner, or because your property is exempt or you are entitled to a discount.

You should not withhold payment if you are making an appeal. You should pay as normal and a refund will be made if you are successful.

## **Changes in circumstances**

If you have been granted a reduction you must tell the Council of any change in circumstances which will affect your entitlement within 21 days. If you fail to do so you may be faced with a penalty of  $\pounds70$ .

#### How we collect and use information

Cannock Chase Council, as the data controller, will use the information that you provide to update your Council Tax account.

We want to be able to provide appropriate, timely and effective services so it is important to us that we co-ordinate what we do for you properly. To do this, we will share basic information such as name and address between services within the Council. This allows us to keep our information on you as up-to-date as possible in order to improve our services to you.

Even though our systems are joined-up, we ensure that staff within the Council can only access the information they need to do their job. Please be advised, we won't sell or give your information to any third party for marketing purposes unless we have asked for your permission.

We will only share your information, when necessary, with agencies involved in the administration of your Council Tax account, or where the law requires or allows us to, for example, to prevent or detect fraud and error within the Council Tax and/or Benefit System.








## **Council Tax valuation bands**

The Valuation Office Agency which is part of HM Revenue and Customs (not your local Council) has put every property into one of eight valuation bands.



The charge for each property band is as follows:-


Your Council Tax bill states which band applies to your home and your home's valuation is based on an estimate of how much it was worth on 1 April 1991. Price changes since that time won't affect the valuation.

In addition a further charge is included for the spending of Parish Councils where appropriate.

## About your Council Tax Bill

Your Council Tax bill comprises charges from four principal authorities in the area, Staffordshire County Council, Staffordshire Commissioner (Police and Crime), Staffordshire Commissioner (Fire and Rescue) and Cannock Chase Council.

Cannock Chase Council is solely responsible for collection of Council Tax.



## How is your District Council charge calculated?

The amount of money required by the Council for 2023/24 to carry out its functions and provide services (its budget requirement) is £13.086 million (£12.425 million in 2022/23).

A proportion of this is met by Business Rates Retention with the balance being met from council taxpayers.



## **Capital Expenditure**

In 2023/24 Cannock Chase Council will be spending approximately £14.996 million on capital investment, which is split £12.772 million on the Housing Revenue Account and £2.224 million on the General Fund Capital Programme.



Areas of investment in the Housing Capital Programme include improvements to existing council housing including upgrading of central heating, kitchens, bathrooms and electrical systems. Funds have also been set aside for external and environmental works, disabled housing adaptations and sheltered scheme works. Areas of Investment on the General Fund Capital Programme include Stadium development works, play areas and the purchase of replacement wheeled bins. Resources will continue to be made available for disabled facilities grants to private householders.

## Borrowing

The Council's total outstanding debt at 31 March 2023 is estimated to be £82 million.

## **Parish Councils**

Parish Councils tell Cannock Chase Council how much income they need from Council Tax (their 'precept'). This is paid for from the District Council's General Fund and is recovered by setting a parish tax for each Parish Council.

The detailed analysis has been provided by Rugeley/Hednesford Town Council in line with the Local Government Act 1992 which requires all Parish/Town Councils with a precept in excess of  $\pounds$ 140,000 to provide details of expenditure and income to Council Tax/national non-domestic rate payers.

## The Environment Agency - Midlands Region

## The Council Tax (Demand Notices) (England) Regulations 2011.

The Environment Agency is a levying body for its Flood and Coastal Erosion Risk Management Functions under the Flood and Water Management Act 2010 and the Environment Agency (Levies) (England and Wales) Regulations 2011.

The Environment Agency has powers in respect of flood and coastal erosion risk management for 2369 kilometres of main river and along tidal and sea defences in the area of the Trent Regional Flood and Coastal Committee. Money is spent on the construction of new flood defence schemes, the maintenance of the river system and existing flood defences together with the operation of a flood warning system and management of the risk of coastal erosion. The financial details are:

A change in the gross budgeted expenditure between years reflects the programme of works for both capital and revenue needed by the Regional Flood and Coastal Committee to which you contribute. The total Local Levy raised by this committee has increased by 2.0%.

The majority of funding for flood defence comes directly from the Department for the Environment, Food and Rural Affairs (Defra). However, under the new Partnership Funding rule not all schemes will attract full central funding. To provide local funding for local priorities and contributions for partnership funding the Regional Flood and Coastal Committees recommend through the Environment Agency a local levy.



## Statement concerning adult social care funding

The Secretary of State made an offer to adult social care authorities (Adult social care authorities' are local authorities which have functions under Part 1 of the Care Act 2014, namely county councils in England, district councils for an area in England for which there is no county council, London borough councils, the Common Council of the City of London and the Council of the Isles of Scilly.)

The offer was the option of an adult social care authority being able to charge an additional 'precept' on its council tax without holding a referendum, to assist the authority in meeting its expenditure on adult social care from the financial year 2016-17. It was originally made in respect of the financial years up to and including 2019-20. If the Secretary of State chooses to renew this offer in respect of a particular financial year, this is subject to the approval of the House of Commons.
