**4. Hackney Carriage Proprietors' Licence – Exceptional Vehicle Application**

Consideration was given to the Not for Publication Report of the Head of Environmental Health (Enclosure 4.1 – 4.28 of the Official Minutes of the Council).

The Licence Holder attended the Hearing to present his case.

The Chairman then invited all those present to introduce themselves and outlined the procedure to be followed at the Hearing. All parties confirmed their understanding of the procedure.

The Officer of the Licensing Authority presented the Council's case by taking the Committee through the report outlining the relevant issues for consideration and Members were asked to consider whether the Applicant's vehicle was exceptional. The Applicant, together with Members of the Committee were offered the opportunity to ask questions of the Officer, there being none, the Committee then viewed the Applicant's vehicle.

The Applicant then presented his case. He advised that the interior and exterior of the car was well maintained, consequently he considered it to be in a good condition and that it was appropriate to apply for an extension. A copy of the service history and log book were circulated at the meeting. Members of the Committee and the Officer from the Licensing Authority were offered the opportunity to ask questions of the Applicant.

The Officer of the Licensing Authority and the Applicant were then afforded the opportunity to sum up their cases.

The Committee then deliberated in private accompanied by the Council's Legal Adviser and Secretary to the Committee. The parties returned to the meeting and the Chairman outlined the decision of the Committee. The Council's Legal Advisor advised the Applicant that he would be written to within seven working days (or as soon as practicable) confirming the Committee's decision and giving reasons for that decision which was as follows:-

RESOLVED:

That, having regard to all the circumstances, the application for a Hackney Carriage Proprietor's Licence be approved for a period of 12 months as the Committee was satisfied that the vehicle was an 'exceptional vehicle' as defined by the Council's policy for the age restriction of Hackney Carriage Vehicles.

REASON FOR THE DECISION:

1. The Committee carefully considered all relevant factors, issues and the responses given by the Applicant. Due regard was also given to the Council's Policy on the age restrictions for

the licensing of Hackney Carriage Vehicles and also to the powers given to licensing authorities under Section 37 of the Town Police Clauses Act 1847 and Section 47 of the Local Government (Miscellaneous Provisions) Act 1976.

2. The Committee was afforded the opportunity of inspecting the vehicle both inside and out and of perusing the service/maintenance records. It was considered that the vehicle had been well looked after and its condition was indeed exceptional, given its age and the mileage which it had covered.
3. The Committee was therefore of the opinion that the Applicant's vehicle satisfies the criterion as an "exceptional vehicle" and that it should therefore be licensed for a period of 12 months.

## **5. Hackney Carriage Proprietors' Licence**

Consideration was given to the Not for Publication Report of the Head of Environmental Health (Enclosure 5.1 – 5.23 of the Official Minutes of the Council).

The Licence Holder attended the Hearing to present his case.

The Chairman then invited all those present to introduce themselves and outlined the procedure to be followed at the Hearing. All parties confirmed their understanding of the procedure.

The Officer of the Licensing Authority presented the Council's case by taking the Committee through the report outlining the relevant issues for consideration and Members were asked to consider whether the Applicant's vehicle was exceptional. The Applicant, together with Members of the Committee were offered the opportunity to ask questions of the Officer, there being none, the Committee then viewed the Applicant's vehicle.

The Applicant then presented his case. He advised that the vehicle was in a good condition for its mileage and was serviced regularly and well maintained, consequently he considered it appropriate to apply for an extension. The vehicle's registration document was circulated at the meeting. Members of the Committee and the Officer from the Licensing Authority were offered the opportunity to ask questions of the Applicant.

The Officer of the Licensing Authority and the Applicant were then afforded the opportunity to sum up their cases.

The Committee then deliberated in private accompanied by the Council's Legal Adviser and Secretary to the Committee. The parties returned to the meeting and the Chairman outlined the decision of the Committee. The Council's Legal Advisor advised the Applicant that he would be written to within seven working days (or as soon as practicable) confirming the Committee's decision and giving reasons for that decision which was as follows:-

RESOLVED:

That, having regard to all the circumstances, the application for a Hackney Carriage Proprietor's Licence be approved for a period of 12 months as the Committee was satisfied that the vehicle was an 'exceptional vehicle' as defined by the Council's policy for the age restriction of Hackney Carriage Vehicles.

REASON FOR THE DECISION:

1. The Committee carefully considered all relevant factors, issues and the responses given by the Applicant. Due regard was also given to the Council's Policy on the age restrictions for the licensing of Hackney Carriage Vehicles and also to the powers given to licensing

authorities under Section 37 of the Town Police Clauses Act 1847 and Section 47 of the Local Government (Miscellaneous Provisions) Act 1976.

2. The Committee was afforded the opportunity of inspecting the vehicle both inside and out and of perusing the service/maintenance records. Whilst it was noted that the driver's seat and alloy wheels were showing signs of wear, it was clear the vehicle had been well looked after given its age and the mileage which it had covered. The Committee felt the decision to grant the application was a difficult one and asked the Applicant to be mindful and aware that in 12 months time the vehicle may not be classed as exceptional if the issues regarding the driver's seat and alloy wheels were not addressed beforehand.
3. However, the Committee were of the opinion that on this particular occasion the Applicant's vehicle satisfied the criterion as an "exceptional vehicle" and that it should therefore be licensed for a further period of 12 months.
