57. Members requests for Site Visits

58. Application CH/20/305, Land at Lime Lane, Pelsall, WS3 5AT, Change of use of the land to a Gypsy and Traveller residential site with the siting of up to ten caravans of which no more than five would be static caravans, the construction of a utility block, and the creation of a new vehicular access and the laying of hard standing

(The Chairman delayed consideration of this application in order to allow Councillor A. Dudson to join the meeting as he was having difficulty connecting. However, as he was not able to join the Chairman decided to continue to determine the application in his absence).

Consideration was given to the report of the Development Control Manager (Item 6.1 - 6.49 of the Official Minutes of the Council).

The Development Control Manager advised that an update had been circulated to Members in advance of the meeting. The update was as follows: -

"Response of Natural England

Natural England notes that your authority, as competent authority, has undertaken an appropriate assessment of the proposal in accordance with Regulation 63 of the Conservation of Species and Habitats Regulations 2017 (as amended). Natural England is a statutory consultee on the appropriate assessment stage of the Habitats Regulations Assessment process.

Your authority has concluded that the evidence provided with the proposal and confirmed by the LLFA demonstrates that the proposal would not have a significant impact on the integrity of Cannock Extension Canal SAC.

Having considered the assessment Natural England advises that we concur with the assessment conclusions".

He then provided a presentation to the Committee outlining the application showing photographs and plans of the proposals.

Prior to consideration of the application representations were made by Councillor J. Newbury (Ward Councillor) speaking in favour of the application. Further representations were made by Nial Casselden and Michael Hargreaves (representing the applicant) who both spoke in support of the application and shared the ten minutes between them.

RESOLVED:

That, as no objections have been received from Natural England, the application be approved subject to the conditions contained in the report for the reasons outlined therein and the completion of a unilateral undertaking to secure mitigation against the impacts of visitor pressure on Cannock Chase SAC.

(Councillor A. Dudson joined the meeting as some point during the determination of the above application. Therefore, he did not take part in the vote on this application).

59. Application CH/20/247, Land on North-East side of A5 (Turf Roundabout), Watling Street, Cannock, WS11 9ND – Planning application for the retention of gates, fencing and groundworks

The Development Control Manager provided a presentation to the Committee outlining the application showing photographs and plans of the proposals.
