Prior to the commencement of the formal business, the Leader advised that Councillors Newbury and Pearson had been appointed to the Cabinet as the Environment & Climate Change and Crime & Partnerships Portfolio Leaders, respectively, and welcomed Councillor Newbury to his first Cabinet meeting.

144. Apologies

Apologies for absence were submitted for Councillor A.R. Pearson, Crime & Partnerships Portfolio Leader.

145. Declarations of Interests of Members in Contracts and Other Matters and Restriction on Voting by Members

No other Declarations of Interest were made in addition to those already confirmed by Members in the Register of Members' Interests.

146. Updates from Portfolio Leaders

Culture and Sport

Rugeley Swimming Pool

The Portfolio Leader advised that in relation to the problems with the tiling at Rugeley swimming pool, of which Members were aware, the Council and Inspiring Healthy Lifestyles (IHL) had issued a joint press release last week about the problems. IHL had arranged for a pressure test of the pipework to be undertaken, followed by further investigations, after which more details would hopefully be known.

Green Lane Play Area

The Portfolio Leader advised that Rugeley Town Council was pressing ahead with the works to the play area at Green Lane.

Queen's Award

The Portfolio Leader advised that the Friends of Hednesford Park had been awarded the prestigious 'Queen's Award for Voluntary Service'.

The award was the highest that could be given to volunteer groups across the UK, with a total of 230 organisations receiving the award this year.

The award coincided with Volunteer's Week, which took place from 1 to 7 June. The award recognised the tremendous hard work and dedication put in by the volunteers who worked tirelessly to support the local community.

Particular thanks was given to Lynn Evans and the Team involved with the Friends of Hednesford Park, a sentiment which was echoed by the Leader of the Council.

New Cemetery

The Portfolio Leader advised that contractors were due to start work on-site next week for the new cemetery at Hednesford Road / Norton Road.

Economic Development and Planning

<u>Unemployment</u>

The Portfolio Leader advised that sadly, the effects of the COVID-19 pandemic were now being felt within the local economy. The unemployment data for May was published on 16 June and showed that a further 980 residents were now out of work, bringing the total to 3,980. This equated to an unemployment rate of 6.3%, which was just under the national rate of 6.5%. Since March, 2,325 residents had become unemployed, with 14,800 of the District's workers furloughed – this position was expected to increase further. The Council would be working with key partners to help those affected and to also develop an economic recovery plan that could set out how the District's economy could get back on its feet.

CCDC Discretionary Fund

The Portfolio Leader advised that the Council had launched a £1 million grant scheme to support small businesses. The first phase of the fund prioritised occupiers of shared spaces, market traders, bed and breakfast establishments who did not pay business rates, and charities who were not eligible for Small Business Rate Relief or grants – so far 30 applications had been received and small numbers of new applications were coming in each day. On 22 June, the fund would open up to more businesses – particularly focusing on small businesses with up to 50 employees and manufacturing/engineering sectors and protecting existing jobs was a key priority.

GBSLEP Pivot and Prosper Fund

The Portfolio Leader advised that the Council was working with the Greater Birmingham and Solihull Local Enterprise Partnership (GBSLEP) to promote a number of new initiatives to support business recovery. A new £2 million 'Pivot and Prosper' fund had been launched today by GBSLEP which was available to businesses across the GBSLEP area, including Cannock Chase. The fund gave businesses the opportunity to apply for funding of up to £40,000 and was

designed to help businesses 'pivot' to new ways of working and change business models, to safeguard existing jobs as well as creating new jobs. Businesses in the District were encouraged to look at this opportunity further and contact the Council's Economic Development team or the GBSLEP Growth Hub for further information.

Housing

Hawks Green Depot Site

The Portfolio Leader advised that clearance works for the Council housing scheme at the Hawks Green Depot had completed, and re-organisation works had nearly finished.

Town Centre Regeneration

Re-opening of Town Centres

The Portfolio Leader advised that he town centres in the District had started to re-open with non-essential retailers opening their doors to shoppers from 15 June. The Council had worked with Staffordshire County Council to make the town centres as safe as possible, and installed signage to remind people of the need to maintain social distancing, as well as trying to remove any pinch-points on pavements so that shoppers had sufficient space to move around.

Officers had been out and about this week and working pro-actively with businesses and traders to ensure that their premises were safe and adhered to the COVID-19 secure guidelines and actively managed issues such as queuing of customers outside of the shops. Compliance had been very good and businesses had responded well to the challenge of adapting their premises and keeping their customers and staff safe, by putting in place one way systems, floor markers and protective screens at the tills.

Officers had visited well over 70 businesses during the last week and there was a number of photos on the Council's Facebook page. Over the next couple of weeks, Officers would be advising and supporting licensed premises, hairdressers, cafes/restaurants in anticipation of them re-opening on 4 July, subject to Government approval.

Finally, the Cannock Street market was due to re-open on 19 June, and Officers had worked with the operator, Sketts, to put in place all of the appropriate risk assessments, social distancing measures and a new layout to manage queuing safely. Initially there would be 20 traders and the location of the market was temporarily moving to Market Place to allow for adequate social distancing along Market Hall Street.

PRIORITY DELIVERY PLANS -

OUTTURN FOR 2019/20 AND REVISIONS FOR 2020/21

1 Purpose of Report

1.1 To advise Members on the position at the year end for 2019/20, in respect of the Priority Outcomes as set out in the Corporate Plan 2018-23 and present revised Priority Delivery Plans (PDPs) for 2020/21.

2 Recommendation(s)

- 2.1 To note the performance information relating to PDPs for 2019-20 as detailed at Appendices 1a-1d.
- 2.2 Cabinet is asked to recommend to Council that the revised Priority Delivery Plans for 2020-21 as detailed in Appendices 3a to 3d be approved.
- 2.3 To note the officer capacity issues and to agree the short to medium term solutions set out in 5.15.

3 Key Issues and Reasons for Recommendations

Key Issues

- 3.1 The overall position for the Priority Delivery Plans for 2019/20 indicates that in total, 79% of all actions have been achieved or are in progress with minor slippage. The detail for each of the PDPs is set out in the table at 5.3.
- 3.2 Considerable changes have occurred since the Cabinet approved the Priority Delivery Plans (PDPs) for 2020/21 on 18 March 2020. The Council has had to respond to the national COVID-19 pandemic. This has meant that with few exceptions, none of the approved PDP priorities for 2020/21 have been able to

be progressed so far this year. Consequently the PDPs need to be reviewed in light of the impact of the pandemic and the addition of "Supporting Recovery" as the overarching priority of the Council.

Reason for Recommendations

3.3 The Priority Delivery Plans (PDPs) are the annual documents that set out how the Council will achieve progress against the strategic objectives set out in the Corporate Plan for 2018-23. These plans establish the actions, performance measures and timetables for delivery that are the basis of the Council's quarterly and annual performance reporting framework.

4 Relationship to Corporate Priorities

- 4.1 This report supports the Council's Corporate Priorities as follows:
 - (i) The Corporate Plan sets out the Council's mission, priorities and strategic objectives for the period 2018-23, and is therefore a central element of the corporate priority planning process. The PDPs form the annual mechanism for reporting and monitoring progress in regard to these priorities.

5 Report Detail

Priority Delivery Plans 2019-20 – Year End Position

- 5.1 The Council's Corporate Plan 2018-23 was approved by Cabinet on 19 April 2018, setting out the mission, priorities and strategic objectives of Cannock Chase District Council for the next five years.
- 5.2 The supporting Priority Delivery Plans (PDPs) are the annual documents that set out how the Council will achieve progress against its strategic objectives; these plans establish the actions, performance measures and timetables for delivery that are the basis of the Council's quarterly and annual performance reporting framework.
- 5.3 The Lead Officers for each of the projects / actions have provided a commentary on performance in delivering the PDPs for 2019/20 and a rating. A summary of progress, by rating, is given in the table below. This shows that 69.8% of actions have been delivered and a further 9.2% are in progress and will be completed with only minor slippage. Further details including the performance in Quarter 4 are included in Appendices 1a-1d.

Priority Delivery Plans 2020-21

- 5.4 The Council's priorities and objectives are set out in the Corporate Plan 2018-23. Whilst the priorities remained the same, the objectives were updated in March 2020 to bring the objectives for Promoting Prosperity into line with the themes set out in the Economic Prosperity Strategy and to add the objective regarding the Council's commitment to becoming net carbon neutral by 2030. Since the update in March 2020, and in response to the pandemic, Cabinet approved on 21 May 2020 "Supporting Recovery" as its overarching priority. A Recovery Overview Board has been established to oversee all work on this. The Council's current priorities and objectives are outlined in Appendix 2.
- 5.5 Considerable changes have occurred since the Cabinet approved the Priority Delivery Plans (PDPs) for 2020/21 on 18 March 2020. The Council has had to respond to the national COVID-19 pandemic. This has meant that with few exceptions, none of the approved PDP priorities for 2020/21 have been able to be progressed so far this year. Consequently the PDPs need to be reviewed in light of the impact of the pandemic.
- 5.6 The Council remains in response phase for COVID-19 and is also at the early stage of the recovery phase; the two will run in parallel for some time. Whilst the detail is not clear yet, the Council needs to prepare to deal with the very significant economic and financial consequences of the pandemic. Taking these all together, it places a significant pressure on officers across the Council in addition to their more routine duties.

- 5.7 As a result of COVID-19, there are also backlogs across some service areas in the Council that will need to be addressed but this could take some time to address as officer capacity is stretched across Response and Recovery. A significant amount of annual leave has had to be cancelled in order to prioritise officer capacity to deal with response so there is also a backlog of untaken leave across many service areas of the Council.
- 5.8 Like most Councils, Cannock Chase is significantly stretched in terms of officer capacity to address Response, Recovery and progress some of the Council's priorities. The impact of COVID-19 has exacerbated a pre-existing capacity issue. Consequently critical short term priorities linked to COVID-19 and the maintenance of essential Council services are being delivered, whilst other priorities are either not being delivered or are being delivered much more slowly.
- 5.9 The focus of the Council over coming months is on Recovery, alongside continuing to support the response, and hence in light of the above capacity issues there will need to be trade-offs between different priorities, some projects may take longer to deliver and it is unlikely that any new priorities can be progressed at the current time.
- 5.10 The Priority Delivery Plans have been reviewed in light of events over the last few months and the challenges that the Council and the District are facing in the coming months to allow resources to be prioritised to where they are most needed.
- 5.11 The Leadership Team has undertaken an initial assessment of the PDPs that were approved in March and, in consultation with the Recovery Overview Board, have identified proposals for consideration by Cabinet in relation to projects that could:
 - Continue as planned;
 - Continue but with some slippage;
 - Need to be deferred; and
 - Need to be re-framed in the context of the recovery plans.
- 5.12 The assessment of each of the PDPs is set out in Appendices 3a-3d. This is a provisional assessment and may well change as work on the response phase continues and the recovery planning develops.
- 5.13 Those items from the 2020/21 PDPs that have been identified as needing to be considered and actioned as part of the Council's work on recovery, will be removed from the PDPs. Progress in delivering these will be reported on through the relevant recovery work streams.
- 5.14 As well as reviewing the PDPs, the Strategic Risk Register has been updated to reflect the impact of the pandemic on the Council and it's priorities; this is the subject of a separate report.

- 5.15 Capacity has been identified as a key strategic risk and the short to medium term solution is to progress the following:
 - Recognise the critical need for officers to prioritise the response to and recovery from COVID-19;
 - establish clear agreement with Cabinet on a revised set of PDP priorities for 2020/21; recognising that 2020/21 will be a year of limited delivery as a result of the impact of COVID-19;
 - agree a moratorium on new projects and pieces of work unless agreed and resourced as a Recovery priority;
 - Develop a financial recovery plan for 2020/21 and beyond that addresses the impact of COVID-19;
 - Discuss /agree the appetite of Cabinet and Council in 2020/21 for a transformation programme including the necessary resources and expertise that will be necessary depending on the level of transformation;
 - Progress the work in 2020/21 that has stalled on Climate Change to deliver a 10 year action plan and to have a greater degree of clarity than currently exists now on the resources and expertise required to deliver a major change programme;
 - Conduct a review of management capacity in 2020/21 and present to Members for consideration taking into account the further clarification of the Council's priorities, a better level of clarity on the Council's financial position, ambition for transformation and the delivery of a climate change action plan during the 2020/21 financial year.

4 Relationship to Corporate Priorities

- 4.1 This report supports the Council's Corporate Priorities as follows:
 - Risk management is a systematic process by which key business risks / opportunities are identified, prioritised and controlled so as to contribute towards the achievement of the Council's aims and objectives.
 - (ii) The strategic risks set out in the Appendices have been categorised against the Council's priorities.

5 Report Detail

5.1 The Accounts & Audit Regulations 2015 state that:

"A relevant body must ensure that it has a sound system of internal control which:-

- (a) facilitates the effective exercise of its functions and the achievement of its aims and objectives;
- (b) ensures that the financial and operational management of the authority is effective; and
- (c) includes effective arrangements for the management of risk."
- 5.2 Risk can be defined as uncertainty of outcome (whether positive opportunity or negative threat). Risk is ever present and some amount of risk-taking is inevitable if the council is to achieve its objectives. The aim of risk management is to ensure that the council makes cost-effective use of a risk process that has a series of well-defined steps to support better decision making through good understanding of risks and their likely impact.

Management of Strategic Risks / Opportunities

- 5.3 Central to the risk management process is the identification, prioritisation and management of strategic risks / opportunities. Strategic Risks are those that could have a significant impact on the Council's ability to deliver its Corporate Priorities and Objectives.
- 5.4 A fundamental review of the strategic risks/opportunities facing the Council has been undertaken to take account of the impact that the pandemic and the lockdown arrangements are having. The risks have been scored and action plans put in place to ensure that they are managed effectively. A summary of the Council's strategic risk register as at 31 May 2020 is attached as **Appendix 1**.
- 5.5 The risk summary illustrates the risks / opportunities using the "traffic light" method i.e.
 - RED risk score 12 and above (action plan required to reduce risk and/or regular monitoring)
 - AMBER risk score 5 to 10 (action plan required to reduce risk)

GREEN risk score below 5 (risk tolerable, no action plan required)

- 5.6 The number of strategic risks has increased from 5 to 7 and the key changes are summarised below:
 - One risk has been deleted (risk 16) as the impact of the reform of Benefit payments has now stabilised;
 - Three new risks related to the impact of the pandemic have been added;
 - Four risks have been re-framed to reflect the effects of the pandemic.
- 5.7 The number of risks which have been scored as high (Red) has increased from one to four as a result of the pandemic and the lockdown arrangements:
 - The Council's financial stability is adversely affected in the short and medium term (previously red risk);
 - The economy of the District is adversely impacted;
 - The Council's key contractors remain sustainable and continue to provide value for money; and
 - The Council doesn't have sufficient officer capacity or financial resources to sustain delivery of essential services, key projects and support work on recovery.
- 5.8 The detailed actions plans for each risk are set out in the full strategic risk register attached at **Appendix 2**. This includes a progress update. The action plans are closely aligned to the Council's Recovery plans and will be kept under review.

The Community Vulnerability Hub was established within days of the lockdown. Through Support Staffordshire links with the voluntary sector have been strengthened and residents have been supported with emergency food parcels. 11 Rough Sleepers have been rehoused in hotel accommodation during the pandemic and on-going support is in place to support the Rough Sleepers into permanent accommodation. The Council have sent 4,800 letters to vulnerable residents and this is being followed up with telephone calls to residents who have not made contact.

Throughout the transition period, Community Safety Hub (CSH) attendance has remained strong, with all key stakeholders (Police, Fire and Rescue, Adult Social Care etc.) dialling in. Recent weeks have also seen several other partners embracing the change, thus bringing attendance in line with pre-'lockdown' levels.

The Council continues to respond to a declared Major Incident from March 2020 and this has had an immediate and direct impact on officer capacity as has the impact of Coronavirus on the workforce re remote working / self- isolating / cancellation of annual leave etc. It has placed considerable and continuing pressure on key service areas

Officer capacity has had to be prioritised to deliver an effective response to the Covid19 pandemic and this has meant the delivery of new programmes of work in compressed time periods e.g. business grant payments, supporting NHS Shielding / vulnerable people in the community with the voluntary sector, securing PPE, Test and Trace programme etc.

Work is in progress to review essential services to assess resilience over the next few months. Work has commenced on reviewing the Priority Delivery Plans for 2020/21 alongside the development of Covid19 Recovery work stream plans. At the current time, not all of the Council's PDP priorities can be taken forward due to the various and uncertain impacts of Covid19.

HOUSING REVENUE ACCOUNT – CREATION OF NEW POSTS

1 Purpose of Report

1.1 To seek Cabinet approval for the creation of two posts within the Housing Property Services Team and the Neighbourhoods Team.

2 Recommendation(s)

- 2.1 To approve the creation of two new posts funded within the budgetary provision for the Housing Revenue Account:-
 - Compliance Officer Salary Grade H; 37 hours per week (£42,780 including on costs)
 - Special Complex Case Officer Salary Grade F; 18.5 hours per week (£16,400 including on costs).

3 Key Issues and Reasons for Recommendations

Key Issues

- 3.1 The Housing department currently manage 5,115 properties across our district (as at 31 March 2020). Of these there are 35 blocks of flats with communal areas and 4 sheltered schemes.
- 3.2 A review of the compliance requirements has been undertaken by the Interim Housing Property Services Manager. He has identified that the key compliance tasks are dispersed into various posts across the wider Housing Team.
- 3.3 In recent history, the Grenfell Tower fire in 2017 evoked 'The Independent Review of Building Regulations and Fire Safety' Report (May 2018) highlighting recommendations from Dame Judith Hackett. Particular recommendations with regard to the responsibilities of the duty holder and on producing a reformed

building safety regulatory system add further depth to the Council's role in complying.

- 3.4 The Tenancy Services Team has seen how tenants with complex needs can have a negative impact on resources, neighbourhoods, communities and frontline Council Services because of the high levels of demand generated the tenants. This is demand is also impacting on locality, other public sector providers and wider Council services.
- 3.5 The current pandemic has highlighted that we have several Council Tenants who are challenging because of behavioural issues, complex support needs, mental health or are aggressive to staff. The individuals monopolise the patch based Officer's time, Council Services and other organisations times. According to our records there are currently 10 Council Tenants that fall within this category.

Reasons for Recommendations

- 3.6 The Housing Property Services Team is currently understaffed to deliver compliance across the board. To maintain and further develop the processes it is essential to recruit to a new Compliance Officer position so that focus on all areas can be retained.
- 3.7 The new post holder (Special Complex Case Officer) will ensure that services and teams are able to build resilience by tackling the individuals demand for services and will achieve this by providing a resident centred housing services and link in with other partners to ensure service delivery is coordinated.

4 Relationship to Corporate Priorities

- 4.1 This report supports the Council's Corporate Priorities as follows:
 - (i) The Council has a responsibility to ensure the wellbeing of its community. A role sustaining safe homes and providing a healthy environment to live will assist in contributing to community wellbeing.

5 Report Detail

- 5.1 The Housing department currently manage 5,115 properties across our district (as at 31 March 2020). Of these:
 - c.95% have asbestos containing materials (ACMs) which need to be managed and removed when damaged in accordance with The Control of Asbestos Regulations 2012;
 - c.25% have communal areas and all properties have a party wall requiring fire safety measures and regular risk assessments in accordance with the Regulatory Reform (Fire Safety) Order 2005; and
 - All void and communal facilities will require risk assessments with regard to water hygiene.

- 5.2 As a landlord Cannock Chase District Council has a responsibility to ensure all the above is adhered to inline with H&S at Work etc. Act 1974.
- 5.3 **Compliance Officer** the creation of this role will ensure:-
 - Centralised management, focus and engagement of health and safety risks;
 - The coordination of cyclical testing and risk assessments for Asbestos management, fire safety and legionella risk;
 - Recommendations are addressed in order to prepare and implement relevant work streams and remedial work, to remove and mitigate any risks;
 - Expertise in Asbestos Management, with the ability to offer advise on corporate stock;
 - Accurate, housing stock records relating to compliance;
 - All remedial work and relevant work streams are monitored and therefore compliant.

5.4 **Special Complex Case Officer** - the creation of this role will aim to:-

- Provide an effective and efficient service; giving advice and assistance in relation to all matters concerning anti-social behaviour;
- Prevent homelessness by promoting sustainable communities and neighbourhoods and take a proactive role in the Council neighbourhood initiatives and regeneration activities by working closely with colleagues, tenants, the local community, and other agencies;
- Receive complex case referrals for casework from Line Manager within Tenancy Services and or external agencies;
- Cases be will investigated and appropriate action taken against perpetrators of anti-social behaviour, or challenging behaviour;
- Take a proactive approach to resolving tenant and neighbourhood disputes, and ensuring effective liaison with Police other services, Community partnership, Independent Mediation Service and other agencies;
- Build a rapport with the Council's Housing Needs team and work alongside partners from across the statutory and voluntary sectors to ensure each individual's support needs are identified and addressed effectively.
- 5.5 There is insufficient budget within the HRA Staffing Budget to fund the creation of these two posts. Cabinet are requested to approve an additional budget allocation of £59,180 to fund these two key posts within the Housing Section.

6 Implications

6.1 **Financial**

As set out in the report above there is insufficient staffing budget to accommodate these posts. The principal on which the HRA budgets are based is that any amount above the minimum working balance is contributed as a Revenue Contribution to Capital Outturn (RCCO). This is then used to fund

capital works to dwellings. Therefore any additional staffing cost will reduce the amount contributed to fund capital works.

6.2 Legal

The legal implications are set out in the body of the report.

6.3 Human Resources

The posts of Compliance Officer and Special Complex Case Officer have been evaluated in line with the Council's Job Evaluation Scheme but at the time of writing these evaluations are subject to the outcome of final moderation. It is not anticipated however that the grades of these roles will be subject to change.
