## 18. Application for a Hackney Carriage / Private Hire Driver's Licence

Consideration was given to the Not for Publication Report of the Head of Economic Prosperity (Item 5.1 – 5.14 of the Official Minutes of the Council).

The Chair invited all those present to introduce themselves and then confirmed the procedure for the Hearing.

The Officer representing the Licensing Authority presented the Council's case by taking the Committee and the Applicant through the report, outlining the relevant issues for consideration.

The Applicant, Members of the Committee, and the Legal Advisor to the Committee were then afforded the opportunity to ask questions of the Officer representing the Licensing Authority. Questions were asked by Members only.

The Applicant then presented their case to the Committee.

The Officer of the Licensing Authority, Members of the Committee, and the Legal Advisor to the Committee were then afforded the opportunity to ask questions of the Applicant. Questions were asked by Members of the Committee, the Officer representing the Licensing Authority and the Legal Advisor.

The Officer representing the Licensing Authority and the Applicant then both summed up their respective cases.

The Committee then deliberated in private, accompanied by the Council's Legal Advisor and Secretary to the Committee. The Officer representing the Licensing Authority and the Applicant left the room during the deliberations.

At the conclusion of the deliberations, the Officer representing the Licensing Authority and the Applicant returned to the room, and the Chairman announced the decision of the Committee, as follows:

### Resolved:

That the application for the grant of a licence to drive hackney carriage/private hire vehicles under sections 51(1)(a) and 59(1)a of the Local Government (Miscellaneous Provisions) Act 1976 **be refused.** 

#### **Reasons for Decision**

The Applicant was afforded the opportunity throughout the hearing to confirm why they considered themselves to be a 'fit and proper' person and to provide compelling reasons for consideration by the Committee to enable it to deviate from its Policy. Nothing was forthcoming in this regard.

The Committee further considered the provisions of the 1976 Act and the Council's Licensing Policy, the Department of Transport Standards and the Institute of Licensing Guidance and the responses given by the Applicant to questions tendered.

The Committee therefore determined not to deviate from Policy and pursuant to Section 51 and 59 of the Local Government (Miscellaneous Provisions) Act 1976 to refuse the application for the grant of a Hackney Carriage Private Hire Drivers Licence. The Committee therefore concluded that the Applicant was not a 'fit and proper' person to hold a licence to drive hackney carriage and private hire vehicles.

4. Licensing Act 2003 – Application for a Premises Licence - J.L Brown Enterprises Ltd, Micro Pub / Neighbourhood Bar, 65-67 Lodge Road, Brereton, Rugeley, Staffordshire, WS15 1HR

The Chair asked all parties present to introduce themselves and to confirm their understanding of the procedure for the Hearing, which had been circulated to all parties in advance.

The Officer representing the Licensing Authority then presented the report of the Head of Economic Prosperity in respect of the application and outlined the relevant matters for consideration (Enclosure 4.1 - 4.93 of the Official Minutes of the Council).

Objectors present at the meeting were given the opportunity to ask questions of the Officer representing the Licensing Authority who presented the report. The Applicant and Members of the Sub-Committee were afforded the opportunity to ask questions of the Officer representing the Licensing Authority. Questions were asked by Objectors and Members of the Sub-Committee.

The Applicant then presented his case to the Sub Committee. Objectors present at the meeting were given the opportunity to ask questions of the Applicant, and Members of the Sub-Committee were given the opportunity to ask questions of the Applicant. Questions were asked by Objectors and Members of the Sub-Committee.

Objectors present at the meeting were given the opportunity to present their respective cases. The Applicant and Members of the Sub-Committee were given the opportunity to ask questions. Members of the Sub Committee asked questions.

The Officer representing the Licensing Authority, the Applicant, and any Objectors were then given the opportunity to sum up their respective cases. Summation was provided by the Officer, Applicant and Objectors.

Members of the Sub-Committee then deliberated in private, accompanied by the Legal Advisor and Secretary to the Sub Committee.

All parties then returned to the meeting and the Chairman announced the decision of the Sub-Committee as follows:

#### Resolved:

That the application for a Premises Licence be granted.

#### **Reasons for Decision:**

The Sub-Committee was concerned with the four Licensing Objectives when making its decision, noting the concerns raised by residents related to 'what might happen' and were therefore not evidence based.

As such, the Sub-Committee determined that the representations made were not evidence based, and so there was no evidence of a failure to promote the Licensing Objectives relating to the Premises or nuisance behaviour derived from the Premises; there were no recorded issues relating to the Licensing Objectives specifically arising, in line with licensing legislation, at the Premises.

The Sub-Committee considered the negotiated conditions of Staffordshire Police and Environmental Health and deemed these as both necessary and relevant in the promotion of the Licensing objectives. In view of this, the Sub-Committee was satisfied that the Premises Licence should be granted, in its entirety, subject to the agreed conditions. The Sub-Committee accepted the negotiated conditions of Staffordshire Police and Environmental Health and the standard conditions in place for the Council's Licensing Department.
