<p><b>Securities</b>            Any beneficial interest in securities* of a body where -            (a) that body to your knowledge as a councillor, has a place of business or land in the area of the council, and            (b) either -            (i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body, or            (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you as a councillor, or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	NIL	NIL
