<p>Securities</p> <p>Any beneficial interest in securities* of a body where -</p> <p>(a) that body to your knowledge as a councillor, has a place of business or land in the area of the council, and</p> <p>(b) either -</p> <p>(i) the total nominal value of the securities* exceeds £25,000 or one hundredth of the total issued share capital of that body, or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you as a councillor, or your spouse or civil partner or the person with whom you as a councillor are living as if they were spouses / civil partners have a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	NIL	NIL
