

<p><b>Licences</b> (Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.)</p> 		
<p><b>Corporate tenancies</b> (Any tenancy where to your knowledge) - (a) the landlord is the relevant authority; and (b) the tenant is a body in which the relevant person has a beneficial interest.</p> 		
<p><b>Securities</b> (Any beneficial interest in securities of a body where - (a) that body where to your knowledge has a place of business or land in the area of the relevant authority; and (b) either - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>		

# Personal Interests




You have a personal interest in any business of your authority where either:

(a) it relates to or is likely to affect:-

	Nature of Interest
(i) Any body of which you are a member or in a position of general control or management and to which you have been appointed or nominated by your authority.	
(ii) Any body exercising functions of a public nature.	
(iii) Any body directed to charitable purposes.	
(iv) Any body whose principal purposes include the influence of public opinion or policy (including any political party or trade union), of which you are a member or in a position of general control or management.	

(b) a decision in relation to that business might reasonably be regarded as affecting your wellbeing or financial position or the wellbeing or financial position of a relevant person to a greater extent than the majority of council tax payers, ratepayers, or inhabitants of the electoral ward affected by the decision.
