**157. Application CH/10/0364, Residential Development (outline including access) Rumer Hill Industrial Estate, Walsall Road, Cannock**

Following a site visit by Members of the Committee consideration was given to the Report of the Planning Services Manager (Enclosure 6.1 – 6.13 of the Official Minutes of the Council).

Prior to consideration of the application representations were made by an objector and the applicant's representative.

The Planning Services Manager provided the Committee with an update. He explained that an additional letter of objection had been received which the objector had also forwarded to all Members of the Committee. The letter added further additional points of concern and these were summarised for the benefit of Members. He also reported that the applicant had requested that Condition 1 be amended to allow the time limit to be extended from 3 years to 5 years. Officers had no objection to this.

RESOLVED:

- (i) That the applicant be requested to enter into a Section 106 Agreement under the Town and Country Planning Act, 1990 to provide for affordable housing as a component of the housing mix on the site, a financial contribution towards improving existing play areas within the adjoining Rumer Hill Estate and a financial contribution to maintenance of the open space to be provided on the site;
- (ii) On completion of the Agreement the application be approved subject to the conditions contained in the report for the reasons stated therein.

(Councillor G.D. Ball requested that his name be recorded as having voted against this decision).

**158. Application CH/11/0029, Eleven non-illuminated fascia signs, Unit 5, Ash Park, Hyslop Close, Cannock**
