CANNOCK CHASE COUNCIL CONDITIONS OF LICENCE FOR A SEX SHOP

- 1. In these conditions "The Council" shall mean the Cannock Chase District Council and all enquiries concerning this licence shall be directed to the Licensing Unit, Civic Centre, Beecroft Road, Cannock, Staffs, WS11 1BG. Phone: 01543 464244. Email: Licensingunit@cannockchasedc.gov.uk
- 2. These conditions are imposed by the Council pursuant to its powers under paragraph 13 (1) of Schedule 3 to the Local government (Miscellaneous Provisions) Act 1982 and apply to all premises licensed as a "Sex Shop" as defined by the Act save and insofar as they do not conflict with any special conditions forming part of the Licence nor with the provisions of the Act itself.
- 3. The licensed premises shall not be open or used for the purposes for which the licence is granted except between the hours of 10am and 6pm on any weekday (including Saturday).
- 4. The licensed premises shall not be so open or used at all on Sundays, Good Friday, Christmas Day or any other general or public holiday.
- 5. The licence or a clear copy shall be conspicuously exhibited at all times to the satisfaction of the Council in the premises, in such a position that it can be easily seen by all persons using the premises.
- 6. No person under 18 years of age shall be admitted to the premises.
- 7. Except as provided for in sub-paragraphs (a)-(c) below no advertising material, sign, graphic or pictorial display whatsoever referring to the premises or to the goods, articles or services provided therein shall be displayed outside, near to or within the premises in such a position or manner as to be visible to any person lawfully using any street, highway, close, yard, court, footpath or place to which the public has access for the time being.
 - (a) The business or trading title of the premises which must have received written approval of the Council may be displayed.
 - (b) A sign <u>must</u> be displayed on the entrance to the premises stating: "NO PERSON UNDER 18 YEARS ADMITTED".
 - (c) A sign indicating the current opening times of the premises <u>must</u> be displayed on the entrance to the premises.

- 8. All windows, doors or other means by which the interior of the premises would otherwise be visible to any person lawfully using any street, highway, close, yard, court, footpath or place to which public has access for the time being shall be obscured or screened in such a way as to prevent the interior of the premises or any article, material or display therein from being visible to any such person.
- 9. Persons resorting to the premises must not have access to or from any premises used for any other business.
- 10. The written permission of the District Council for the conversion of a shop to a cinema or vice versa must be obtained before such conversion is carried out.
- 11. (a) For a sex shop the shop must not be used as a sex cinema and no moving picture, moving display nor recorded sound of any description, howsoever produced, shall be permitted upon the premises except for the bona fide purpose of demonstration only to a prospective purchaser hirer or borrower of the article in question but not further or otherwise.
 - (b) For a sex cinema the cinema must not be used as a sex shop and no articles of any kind may be sold or advertised for sale on or near the premises without the prior written permission of the District Council.
- 12. The premises shall at all times comply with all requirements of the Fire Officer.
- 13. The licence holder shall at all times keep and maintain at the licensed premises a written record of the names, addresses, and dates of birth of all persons employed within the licensed premises whether upon a full or part basis and shall upon request by an authorised officer of the Council make such records available for inspection to him.
- 14. The Licence holder shall at all times provide the Council with written notification as to the names, addresses and dates of birth of such person or persons (whether employees or otherwise connected with the business) who have authority to manage the premises in the licence holder's absence.
- 15. The Council may at any time, waive, modify or vary these conditions or impose additional conditions in any particular case.
- 16. In these Regulations the words "sex shop" and "sex cinema" have the meanings ascribed to them in Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982.
